- Spring jury information: Vickie reported that the Gallery Committee met to organize the
 next jury session. It will be held on Monday and Tuesday, February 26-27, 2018 in the
 Art Education Center. The Call for Exhibit will be publicized no later than November 18,
 2018. The deadline for applying will be February 9, 2018. The gallery committee
 discussed ways to increase the applicant pool and improve the jury process.
- Susan stated that we need to recruit an exhibiting or associate member with good Excel skills to take over the monthly sales spreadsheet report duties that Walt Petersen has been providing.
- Possible changes to the scholarship requirements: Betty Rufus asked for input for the scholarship program. It was suggested that the Call for Scholarship applicants be expanded to target school counselors and teachers with disseminating the information, home school students and Nassau County students attending schools in Duval County

per our current residency requirements. It was suggested that the Letter of Recommendation be accepted from a non-related person in a supervisory role with the student, not just an art teacher (i.e.: Teacher, counselor, team coach, religious leader, etc.) It was agreed that no transcript should be required since the students must be accepted to a college in order to accept the scholarship through the college. It was agreed that the practice of paying the scholarship directly to the college should continue.

- Bronze Sculptures Concept: Lou Goldman requested support for urging the city to use
 the post office building as an art center and for commissioning bronze statues in the
 designated public areas for art of Fernandina Beach. After some discussion, the
 president stated that the IAA would be willing to endorse these ideas and request
 participation from its membership. It was discussed that an umbrella organization should
 be in charge with support from the various non-profit and other arts organizations.
- Chamber of Commerce annual awards banquet: Marla asked if there was interest in
 participating in the Chamber of Commerce Annual Awards banquet. After some
 discussion, it was suggested that Barb Wylie determine if members were interested in
 paying the \$65 per person fee, reserve a table for \$580 for 8 people and decorate a
 table. If so, the IAA would participate.
